IRS Offers Free Filing at No Cost to Taxpayers

The Internal Revenue Service Free File began accepting individual tax returns a few weeks ago, giving eligible taxpayers an early opportunity to prepare and file their federal income tax returns ahead of the official start of the 2026 filing season later this month.

While the filing season begins soon, IRS Free File Guided Tax Software allows taxpayers to prepare and submit returns and hold them for electronic filing once the season officially begins.

For 2026, eight private-sector partners are offering guided tax soft-

ware products through IRS Free File to taxpayers with an Adjusted Gross Income of \$89,000 or less in 2025.

Taxpayers with an AGI above \$89,000 can use the Free File Fillable Forms, available beginning Jan. 26. These electronic versions of IRS paper forms are ideal for individuals who are comfortable preparing their own taxes using IRS instructions and publications.

Understanding IRS Free File

Each IRS Free File trusted partner sets its own eligibility require-

ments, which may include age, income, state residency and military status. Taxpayers and active-duty military personnel with an AGI of \$89,000 or less in 2025 can find a free federal filing option; some partners also offer free state tax return preparation and filing.

Claim Tax Credits at No Cost

IRS Free File allows eligible taxpayers to claim valuable tax benefits, including the Earned Income Tax Credit, the Child Tax Credit and other refundable credits. Refundable tax credits can reduce the amount

of tax owed or result in a refund, even if no tax is due.

Taxpayers can find the right product by visiting IRS.gov/freefile and:


choice in everything that we do in life.

Did you let your mind beat you for what you know to be a good opportunity, focusing on superfluous things that don't matter?


Do you feel your progress slipping away? Or, do you understand you *choose* it away?

Mild Sleep Apnea and the Leadership Power of the Pause

Let me tell you about a testimony I heard recently. A man was diagnosed with *mild sleep apnea*. Not severe. Not dramatic. Just... mild.

Most people think sleep apnea is about snoring. It isn't. It's about oxygen deprivation—often mild, gradual, and unseen.

His sleep care specialist didn't prescribe a miracle. Instead, she prescribed a pause: *Lose some weight. Change your rhythm. Get some real rest.*

And the outcome surprised me - and it worked. The man said that for four straight weeks, he stayed awake and alert in church!

Black "Lines" Matter

That "prescription" line matters. Because mild sleep apnea isn't really about sleep. It's about *unseen obstruction*. Oxygen slowly restricted ... until presence disappears.

Leadership suffers from the same condition.

I call it "ego-holism" — unmanaged ego, whether inflated or deflated. Like mild sleep apnea, it rarely announces itself. Not loud. Not arrogant. Often, just . . . mild. Leaders still show up. Still speak. Still decide. But something vital is restricted: humility, listening, and presence.


And that's why transformation, that real leadership change, rarely begins with a bold action, rarely with acceleration. It begins instead with a **strategic pause**."

I call this strategic pause "Targeting the Problem". And the first discipline is simple: Glance back quickly. Look honestly at where fatigue, distraction, or disengagement have crept in unnoticed.

I've been telling this story carefully. And intentionally. Because the truth is, **that man... was me.**

And like many of God's lessons in my life, he didn't start with my mouth. He started with my body.

So before we rush forward, the first leadership move is simple: *glance back quickly*. And then ask: where might I be nodding off in a place I claim devotion?"



Mr. Charles Wayne Scruggs


Mr. Charles Wayne Scruggs was born to the late Reverend and Mrs. Earl Scruggs, Sr. He grew up in Toney, Alabama, and attended Sparkman High School. He attended J.F. Drake Technical College and became a certified welder. Later, he continued his formal education at Calhoun Community College, where he obtained an associate degree in education. He earned a B.S. degree in education from Athens State University.

Mr. Scruggs is a retiree of the Madison County Board of Education, Madison County Career Academy, where he taught welding for over 30 years. His common sense approach in a no non-sense teaching environment; and, adopting the philosophy of "no student left behind", formed the basis of his long and successful career in technical education. Because of the high level of training he provided, Scruggs was a community resource person, called upon by local industries and businesses for employment opportunities for his students. His teaching prepared students to become skilled laborers. He is particularly proud that 80-100 percent of his students either went on to post-secondary school or were hired in welding positions at NASA, Teledyne Brown Engineering, Schwarze Industries, and SCI Systems, to name a few. Scruggs was named 2014 Teacher of the Year among Madison County Schools Teacher & Support

Professionals.

Scruggs is known for his love of fishing. Through obedience to God, he is committed to following Christ, and being a fisher of men, in accordance with Matthew 4:19: "And Jesus said unto them, follow me and I will make you fishers of men." This was demonstrated by being actively involved in the first formal witnessing teams at Antioch Baptist Church, East Chicago, Indiana, and establishing the Witnessing/ Evangelism ministry at the First Missionary Baptist Church, Huntsville, Alabama, both under the leadership and pastorate of Dr. Julius R. Scruggs. Charles organized witnessing teams, and taught witnessing seminars to equip Christian soldiers to reach the unsaved. These teams actively sought out and witnessed to those seeking salvation, and sometimes those who were lost and needed a loving word from God.

Scruggs is an anointed, gifted, and inspiring teacher. His effective and "tell it like it is" teaching, led to his becoming a faculty member for the National Baptist Congress of Christian Education, where he taught Evangelism and Church Growth for more than 10 years. His classes included pastors and lay ministers, and the impact of his teaching can be found in churches committed to bringing souls to Christ, throughout the United States. Scruggs' dedication to making disciples can be



found throughout the community. He is a sought-after guest Vacation Bible School teacher, and he conducts Evangelism Seminars for churches and outreach ministries. Scruggs has touched thousands of lives and has led countless souls to Christ. He continues to serve at First Missionary Baptist Church as a deacon, Sunday School teacher, Evangelism/Witnessing coordinator, Bible Study teacher, and in other outreach ministries.


Scruggs, since his retirement, has turned his attention to farming. He can be found tending to his cows, his gardens, and helping neighbors. AUNT IRMA MAKES IT PLAIN...

When Healthcare Gets a Velvet Rope

They call it *concierge medicine*, but honey, don't let that soft word fool you. This is not about someone bringing you tea and checking your blood pressure. This is healthcare with a velvet rope, a bouncer, and a monthly cover charge.

Concierge medicine is when doctors charge patients a yearly fee—often between \$1,500 and \$10,000—for “enhanced access.” That means same-day appointments, longer visits, and direct phone or text access to your doctor. It sounds lovely. And for folks with money, it is.

But let Aunt Irma pull the curtain back.

This trend didn't rise because doctors suddenly got more caring. It rose because traditional medicine is breaking under corporate pressure. Doctors are **drowning in paperwork, insurance rules, and patient loads** so heavy that many barely have 10 minutes to look you in the eye. Concierge medicine lets doctors escape that grind by shrinking their patient list—sometimes from 2,500 patients down to 300—and charging those 300 people for the



privilege.

That's good for doctors. It's good for wealthy patients. But for everyone else, especially Black communities, it's a warning bell.

Here's why.

Black Americans already face longer wait times, fewer specialists, underdiagnosis, and higher rates of chronic illness. We don't suffer because we don't value health; we suffer because the system was never designed to serve us equally. Now concierge medicine is quietly siphoning off many of

the best physicians into private clubs for the well-insured.

What happens to the rest of us when experienced doctors leave the general pool? We get what's left: overworked clinics, rushed visits, and care that's more reactive than preventive.

And let's talk about money. Many Black families are middle-class on paper but financially stretched in reality—student loans, family obligations, medical debt, rising housing costs. A \$2,000 annual concierge fee might not sound

outrageous to Wall Street, but to a Huntsville household juggling college tuition, aging parents, and a leaky roof, it's another barrier to dignity.

That creates a new kind of segregation—not by law, but by credit card.

Now, don't misunderstand Aunt Irma. There are Black doctors opening concierge practices to serve Black patients better. That can be powerful. Personalized care, longer conversations, and culturally competent medicine save

lives. But if this model becomes the norm, not the exception, we risk a future where high-quality healthcare becomes something you subscribe to like Netflix.

And, when healthcare becomes a luxury product, history tells us who ends up in the discount aisle.

So what should we be doing?


We should demand stronger public clinics, better insurance reimbursement, and incentives that keep good doctors in underserved communities. We should

support Black physicians who are trying to innovate without abandoning their people. And we should watch carefully as medicine turns into a two-tier system—one for those who can pay extra, and one for those who can't.

Because once health becomes a membership club, sickness becomes a sentence.

And Aunt Irma doesn't believe anybody in this Valley should have to swipe a platinum card just to be treated like a human being.

Local ADC Unit Clarifies 2026 Qualifying Process for May 19 Democratic Primary

The Alabama Democratic Caucus (ADC) -Madison County Unit is initiating efforts to inform the local Democratic electorate of the opportunity to run for a seat on the Madison County Democratic Executive Committee (MCDEC).

MCDEC is the county committee of the (national) Democratic Party and the Alabama Democratic Party.

ADC's goal is to help the local Democratic Party educate registered voters of Madison County who wish to be known as Democrats about the local party's process for becoming an elected member of MCDEC.

No more than three men and three women (including individuals who are non-binary) who have the most votes from each of Madison County's six county commission districts will serve on the MCDEC. They are **elected officials** that lead the party at the local level.

The qualifying process is very easy to run for this office. You must fill-out and **submit your "Declaration of Candidacy" form** (see below) and pay the qualifying (registration) **fee of \$25**.

By completing these steps, your name will appear on the ballot for the **Democratic Primary on May 19, 2026**. The qualifying timeframe is **January 5 through January 23, 2026**.

Note: MCDEC is not a club. The qualifying fees are not membership dues.

MCDEC is providing guidance to all prospective candidates who attend the **registration and information session on January 15, 2026 at 6 pm at University of Alabama in Huntsville (UAH) Morton Hall**.

Individuals can obtain the required form and submit their fee. If you are unable to attend this session, **you may contact the MCDEC Chair at mcdecbiz@gmail.com** to arrange an appointment to submit your form and fee.

- There are two fields of information on the form with boxes to be checked. **Skip those two fields.**

- Elections to be held on **Tuesday 19 May 2026; Tuesday 16 June 2026**

- The Office is **Madison County Democratic Executive Committee** [include your gender identification of Male, Female, or Non-Binary]

- The District is the **County Commission District where you live.**


