# Washington in a Minute



Here are the top issues in Washington, D.C., this week:

1. The House and Senate are in session. On Monday, the Senate Foreign Relations Committee voted on the nomination of CIA Director Mike Pompeo to be Secretary of State. On Friday, Sen. Chris Coons (D-DE) announced that he would vote no, which likely means the committee will fail to approve the nomination with all Democrats and GOP Sen. Rand Paul (R-KY) opposing him. Nevertheless, Pompeo is expected to ultimately be confirmed by the full Senate after Sen. Heidi Heitkamp (D-ND) announced her support last week. On Wednesday, the House and Senate convened to host a joint meeting for an address by French President Emmanuel Macron. Later in the week, the House took up a 6-year reauthorization of the Federal Aviation Administration, which does not include the House GOP-backed privatization plan for the air traffic control system.

2. President and Mrs. Trump hosted a private dinner for French President Emmanuel Macron and his wife, Brigitte, at George Washington's home, Mount Vernon, which was followed by the first state dinner of the Trump Presidency on Tuesday night for the Macrons at the White House with 150 guests. On Friday, he met with German Chancellor Angela Merkel at the White House, who was expected to urge President Trump not to pull out of the 6-nation Iran nuclear agreement.

3.On Wednesday, the Supreme Court, in its final oral argument of the 2017-18 term, took up Trump v. Hawaii, on the constitutionality of the travel ban that President Trump issued in September 2017, which limited travel to the U.S. by nationals from 8 countries: Libya, Iran, Somalia, Syria, Yemen, North Korea, Venezuela and Chad.

4. Foreign student enrollment in U.S. colleges is expected to drop by 6 percent this year, double last year's decline of 3 percent. Universities are attributing those numbers to the president's anti-immigrant rhetoric, especially his travel ban. Dozens of higher education groups penned an amicus brief on the ban's case before the Supreme Court this week, arguing "that since Trump signed the travel ban, international students have expressed concerns about coming to the U.S. to study, while faculty have turned

down jobs and foreign scholars have pulled out of American academic conferences.

5. The Trump administration is planning to propose a delay of an Obamaera regulation aimed at prodding states to step up their oversight of online colleges. The Education Department has sent to the White House Office of Management and Budget a draft proposed rule that would delay the effective date of the agency's "state authorization" rule governing distance education programs.

6.According to the Washington Post, in a first for a leader of either party in Congress, Senate Minority Leader Chuck Schumer (D-NY) introduced legislation last Friday which would allow states to decide whether to make marijuana available commercially, ending the limbo that marijuana sellers find themselves in after Attorney General Jeff Sessions rescinded Obama-era guidance that prevented federal law enforcement officials from interfering with the marijuana business in states where it had legal status.

7. On Saturday night, the White House Correspondents' Association will host its annual dinner at the Washington Hilton. For the 2ndtime in a row, President Trump will not attend the dinner – but this year is sending White House Press Secretary Sarah Huckabee Sanders, who will sit at the head table.

## Local Alum Performs Alongside Beyoncé

Last weekend, Beyoncé made history as the first African American woman to headline the Coachella music festival, a popular two-weekend gathering in Indio, California. Originally slated to perform last year, the "Single Ladies" singer dropped out after announcing that she was pregnant with twins.

Dubbed "Beychella" by fans, the ground-breaking performance has been compared to music pioneers Prince and Michael Jackson. And if you look close enough, you'll be able to catch Matthew Ashraf, an alumnus of Alabama A&M University in the mix. For her nearly two-hour set, the multi Grammy award-winner paid homage to HBCUs, illustrating the proud culture of institutions like Howard and Spelman. Complete with a marching band, baton twirlers and a step team, Beyoncé gave concert goers a taste of the black college experience while cruising through hits "Get Me Bodied", "Who Runs the World (Girls)" and "Sorry."

Ashraf attended A&M, where he played trombone in the Maroon and White marching band. Throughout the show, he could be seen onstage in the bleachers alongside a sea of band members decked out in yellow hoodie embossed with the Beta Delta Kappa crest, Bey's



fictional Greek-letter organization. Now based in Georgia, the musician writes, produces and performs under the name Mayday Muse.

Days leading up to opening night, sources reported that Beyoncé held 11-hour rehearsals with crew members who were asked to sign non-disclosure agreements. Ashraf wasn't unable to comment about the specifics of the show until after Bey's second show. However, shortly after the performance, Muse posted a short message on social media.

"Well, what can I say but thank you for this experience," Ashraf posted on his Instagram. "I will never forget. Words can't explain ... I'm so humbled to be part of history." For those that haven't seen the historic production, Beyonce's set from weekend on can be streamed online. However, those looking to see Bey close out the festival might be disappointed. Days before her final show, reps confirmed that the set will not be broadcast online.

#### WHCAA Announces Legacy Scholarship

The William Hooper Councill Alumni Association announces the 2018 annual LEGACY Scholarship. All high school seniors who are candidates for graduation
