From the Editor

My knee-sister, Vanessa, was born on September 6, 1956. I was born two years later. We were the youngest of our parents 13 children, so we grew up together. Although I was two years younger, I graduated high school and college one year behind her. That's a long story.

Vanessa married her high school sweetheart after college. He was in the Army, stationed at Ft. Lee, Virginia. She was determined to finish college and marry him. After graduation, she took the next bus to Virginia, where they married there in the Chapel. They had three children, two of whom graduated from Alabama A&M University --our alma mater! We are so proud of them because her oldest child, Cindy (named for my mother, Lucinda), was only 15 when her 38-year-old mother passed away with breast cancer.

Cindy lives and works in Houston, Tex. By now you know how this story ends. Our family was in constant contact with her last Friday and through the weekend. By Monday, the Coast Guard had to take her from her home. The results of Hurricane Harvey were real, had hit home and she had to go. We know that people are praying, the Red Cross is visible, she has signed up with FEMA and her insurance adjuster has been out and rendered her car totaled, and on-and-on. With that said, she is homeless. When that water began to rise in her home she feared for her life. That's pretty scary.



I cannot say I understand, but I do remember the April 27, 2011, tornado that hit Harvest. That's as close to a natural disaster that I have been. When the trees and houses started flying through the air, it was likened to the Wizard of Oz. It was like a fairy tale. Unlike me, who was home with my husband, she was home alone and frightened. Her faith is strong and she stayed in touch with us throughout the process. Thank God for mobile phones! The Coast Guard took her and others from her neighborhood to 'Higher Ground.' When they arrived, the parents of one of her neighbors were there to get their family and invited Cindy to go home with them. Yes, they were neighbors but didn't really know each other. They simply recognized that she was a neighbor and invited her with them.

Now, if anyone wants a good debate, try convincing Cindy that there is no God! These people did not know her, only saw her and knew that she was a neighbor, invited her to go with them to their parents' home, which meant that she didn't have to go to one of the local shelters where they were taking loads of evacuees.

When I hear testimonies like Cindy's, it continues to give me hope and reassures me that there is a generation coming forward that believes in God, believes in hard work, rebuilding and exiting from a crisis, a storm, with its faith intact. She was afraid, but never gave up. She is down, but not out. She is challenged, but not giving up. She has loss so much during her young life, but she still has faith. Some of us mature, learned folks can take some lessons from these young, brave champions: "Weeping may endure for a night, but joy comes in the morning" (Ps. 30:5). Somebody, hold my mule!

Washington in a Minute



Here are the top issues in Washington, D.C., this week:

1. The House and Senate return to session this week after a month-long recess. The House will take up a bill combining the remaining eight FY2018 appropriations bills (for which 900 amendments have been submitted that the House Rules Committee will have to sort out) and a \$7.85 billion Hurricane Harvey relief bill, requested by the White House last Friday night, to include \$7.4 billion for the Federal Emergency Management Agency's disaster relief ac-

count and \$450 million to support the Small Business Administration's disaster loan program for small businesses and homeowners. The House will also this week take on the self-driving car issue for the first time when it considers the "SELF DRIVE Act," which would allow automakers and tech giants to test more self-driving cars on U.S. roads, by granting exceptions to federal safety rules so that they can test, initially, as many as 25,000 experimental vehicles annually (eventually increasing to 100,000 vehicles). The Senate will come back

into session and start off with a vote on a federal judge nomination.

2. President Trump is expected to make a much-anticipated announcement as to the future of the Obama-instituted Deferred Action

for Childhood Arrivals (DACA) program, which since 2012 has allowed about 780,000 immigrants who entered the U.S. illegally as minors to avoid deportation for 2 years and be allowed to apply for work permits. He and Treasury Secretary Steven Mnuchin will also meet with key GOP congressional leaders on tax reform, including Senate Finance Chair Orrin Hatch (R-UT) and House Ways and Means Chair Kevin Brady (R-TX). Tuesday, the President hosted a meeting

of the "Big 4" congressional leadership at the White House with House Speaker Paul Ryan, House Democratic Leader Nancy Pelosi, Senate Majority Leader Mitch McConnell and Senate Democratic Leader Chuck Schumer and then travel to North Dakota for an official event focusing on tax reform. On Thursday, he met with Kuwait's head of state at the White House, Sheikh Sabah al-Ahmed al-Jaber al-Sabah.

3. The Senate Health, Education, Labor, and Pensions Committee held a 2-day hearing (September 6-7) on how to shore up Obamacare entitled "Stabilizing Premiums and Helping Individuals in the Individual Insurance Market for 2018." On August 30, a bipartisan group of 8 governors, led by Ohio's John Kasich and Colorado's John Hickenlooper, sent a letter to Congress calling for immediate steps to make Obamacare coverage more stable and affordable. 4. Higher education will be a big focus of the House Education and Workforce Committee this fall. Rep. Virginia Foxx (R-NC), the chair of the panel, plans to release a rewrite of the Higher Education Act — which will set the table for the debate over reauthorizing the law during this Congress.

5. The Senate Judiciary Committee announced last week that it had reached an agreement with Donald Trump, Jr. to testify in closed session this month (specific date and time TBA) about his meeting

with a Kremlin-linked lawyer during his father's presidential campaign in which he was promised compromising information on Hillary Clinton.

6. Defense Secretary Jim Mattis announced last Tuesday that he is freezing the implementation of President Trump's ban on transgender people serving in the military, saying that he will first establish a panel of experts to provide advice and recommendations on how to carry out Trump's directive. The plan will address both the potential for transgender people looking to serve in the military for the first time and transgender troops who already are serving. A presidential memorandum of August 25 gave Secretary Mattis until Feb. 1, 2018, to present a plan on how to implement the transgender ban.

7. Last week, a San Antonio-based federal judge temporarily blocked the State of Texas from enforcing its ban on "sanctuary cities" pertaining to undocumented immigrants, which was to have gone into effect on September 1. Because of the fear created in the immigrant community by the law, Houston Mayor Sylvester Turner had to reassure residents seeking assistance during Hurricane Harvey that no one would be checked for immigration status or papers at city shelters.

In our public life these days, people have an easy time listening to people they agree with but not necessarily to people whose perspective they believe has no value.

Abrahamic Prayers (an interfaith group where atheism is respected as a faith) offers a safe place to listen to each other, sharing your thoughts with people who beg to differ but want to see what you mean.
