## Toyota Alabama Boosts Manufacturing at Drake

Toyota Alabama boosts advanced manufacturing program at J.F. Drake State Community and Technical College. Two Corolla vehicles and 12 engines, valued at approximately \$200,000, were recently donated to support workforce development and training efforts in the community.

The donated Corollas

and engines were originally used to provide onsite training for team members at Toyota. Now, these products will serve a new training purpose as it supports hands-on learning at Drake State.

## Huntsville Working on Road Restoration

Huntsville, projected to be the largest city in Alabama in the next decade, has been booming with population growth and industry, acquiring the nation's most sought-after job-creating projects, such as the Mazda-Toyota Manufacturing Plant, Polaris, and GE Aviation just--to name a few.

To prepare Huntsville for continued success, Huntsville's leaders continue to look toward innovative infrastructure

approaches to keep ahead of this economic growth. Restore our Roads, Mayor Battle's \$250 million cost-sharing initiative established in 2014 between the City of Huntsville and the State of Alabama, aimed to do just that -- speed up and fund critical road projects in North Alabama. Nine priority road projects -- from the upcoming Northern Bypass extension to the now completed South Memorial Parkway Overpasses -- were identi-

fied by the City and State as the first regional road priorities to benefit from the one of its kind collaboration to improve roadway infrastructure. The effort has succeeded in its goal to raise necessary funds, and now produces around \$25 million per year for critical infrastructure projects. Much of the roadwork on those nine major Restore our Roads projects are now in full swing.



# Washington in One Minute



Here are the top issues in Washington, D.C., for this week.

1. The House and Senate returned to session Monday after being in recess for more than a month. The House will vote, among other items, on a trio of bills to stop the Trump Administration's plan to allow oil and gas drilling along the Atlantic and Pacific coasts, in the Eastern Gulf of Mexico, and in Alaska's Arctic National Wildlife Refuge (which was greenlighted in the 2017 GOP comprehensive tax bill). The House went out of session Thursday afternoon to allow GOP congressmen to travel to Baltimore for a Thursday-Saturday retreat at the Marriott Waterfront Hotel. The big news in the Senate this week is, with 13 business days left in the current fiscal year, the GOP-controlled Senate Appropriations Committee finally started work on 4 of the 12 FY2020 appropriations bills: Defense, Labor/HHS/Education, Energy & Water and State/Foreign Operations.

It has been reported that the Senate adhered to "regular order" and was set to approve 4 appropriations bills each week before the start of the new fiscal year on October 1, while the House, which has passed 10 of the 12 bills, now focused on keeping the federal government open with a continuing resolution that runs through Nov. 22, 2019.

2. Education issues will be highlighted in Congress this week with hearings by the House Financial Services Committee on holding student loan servicers accountable and the House Education and Labor Subcommittee on Early Education, Elementary and Secondary Education on "trauma-Informed practices in education" to help students affected by gun violence.

3. President Trump travelled to Fayetteville, N.C., on Monday for a 7 p.m. campaign rally at the Crown Expo Center to support GOP House candidate Dan Bishop on the eve of Tuesday's special election for North Carolina's

9th congressional district seat. The seat had been vacant since the opening of the 116th Congress, following the refusal of the North Carolina State Board of Elections to certify the results of the November 2018 election in the district due to allegations of electoral fraud. Bishop is running against Democrat Dan McCready and current

polling indicates that the election is a toss-up in a district that stretches from Charlottesville to Fayetteville and has been held by the GOP since 1963. On Tuesday, the President addressed the National Historically Black Colleges and Universities Conference at the Renaissance Washington Hotel and then held a ceremony to swear in new U.N. Ambassador Kelly Craft. On Wednesday, he participated in ceremonies for the 18th anniversary of the 9/11 attacks. On Thursday, the President travelled to Baltimore to speak to House GOP congressmen at their retreat.

4. On Thursday night from 8-11 pm EDT, the top 10 Democratic candidates participated in the 3rd Democratic presidential primary debate at Texas Southern University in Houston, Texas. ABC News and Univision hosted the debate. Each candidate had one minute and 15 seconds to directly respond to questions from moderators and 45 seconds to respond to follow-up questions and rebut-

tals. Candidates gave opening statements, but no closing statements. The 10 candidates were: Biden, Booker, Buttigieg, Castro, Harris, Klobuchar, O'Rourke, Sanders, Warren, and Yang.

5. This Wednesday to Sunday, the Congressional Black Caucus Foundation is holding its 49th Annual Legislative Conference at the Walter E. Washington Convention Center. This year's theme is "400 Years: Our Legacy, Our

Possibilities," which commemorates the arrival of the first enslaved Africans at the Colony of Virginia in 1619. On Saturday night, the Phoenix Awards Gala will honor the Central Park Five and the Rev. Al Sharpton.

6. The Wall Street Journal predicted last week that the Federal Reserve will cut interest rates by another quarter point when it holds its next meeting on September 17-18. The Federal Open Market

Committee cut rates by a quarter point for the first time in more than a decade at its last meeting, but President Trump continues to pressure the Fed to cut rates by at least 1%.




Thank you, TVW readers!

## Sipper or Servant

John 2:9-11

This was billed as the beginning of miracles. The details are quite telling when viewed with Spirit-led illumination. One of the details includes the fact that it was the ruler of the feast or the wedding planner, as we may call it, who first tasted (sipped) the wine that had been transformed from the water in

the jugs, but he did not know where it came from. The other interesting detail is parenthetically positioned into the narrative (verse 9), and that is that the servants who drew the water did know. Sippers are those who benefit from ministry but are clueless as to where it comes from. They are satisfied with simply enjoying the church or worship experi-

ence without investing in it. Servants, on the other hand, are those who do know the origin and Orchestrator of the miracles of ministry. There are the preacher/pastors and teachers who do the hard work of preparation and prayer and fasting. They know where the power of their proclamation comes from. Therefore, while appreciating the compliments that come from those who they minister to, they are not saturated with self-aggrandizement. Rather they are thankful for the opportunity to serve God with the gifts they have been given. This

is true with every spiritual gift that is used for God's glory and the edification and equipping of the saints. The bottom line is that the choice belongs to every individual believer to be either a sipper or a servant.
