## NACEE Holds Vets Appreciation Luncheon

The North Alabama Center for Educational Excellence (NACEE) held its 15th Annual Veterans Appreciation Luncheon on Friday, November 5, at the Redstone Federal Credit Union Redstone Room at 220 Wynn Drive.

Retired Major General Patrick W. Burden (Army Future Command, director, Combat System) was the guest speaker.

Burden discussed his leadership philosophy. First on an extensive list is the need to keep people first. Secondly, Burden told the audience of about 75 people

The retired major general said it is paramount to be a team player, to communicate, to make honest mistakes, and to set high

## Washington in One Minute



Here are the happenings in Washington, D.C., this week:

1. **ON THE FLOOR.** The House and Senate were in recess this week in observance of the Veterans Day federal holiday on Nov. 11 and will reconvene next week. Around midnight last Friday, the House passed the \$1.2 trillion Infrastructure Investment and Jobs Act by a vote of 228-206 (with 13 R's voting aye and 6 D's voting nay), sending the measure to the President. Early Saturday morning, the House also passed a rule 221-213 on the \$1.85 trillion Build Back Better (BBB) Act in a straight party line vote that will allow for a vote on that bill later this month. According to The Hill newspaper, House Democrats made changes late Thursday on prescription drug pricing reform to add an additional year of exclusivity before Medicare will be able to negotiate prices for certain biologics, moving the total from 12 years to 13 years and also made a late change to raise the cap on the state and local tax deduction from \$10,000 to \$80,000, and to have that limit be in place at that level through 2030 (a previous version of the bill released Wednesday would have set the cap at \$72,500 through 2031).

2. **THE WHITE HOUSE.** On Friday, President Biden delayed his planned departure to his beach house in Delaware to stay in Wash-

ington to lobby Members of the House on the infrastructure bill, which passed the House that same night. On Monday, President Biden welcomed the Milwaukee Bucks to the White House to commemorate their 2020-21 NBA championship season (the Bucks will be the first NBA team to visit the White House since the Cleveland Cavaliers were honored on Nov. 11, 2016). First Lady Jill Biden was scheduled to begin a nationwide effort by the Biden Administration to encourage COVID-19 vaccinations among children ages 5 to 11 with a stop Monday at the pediatric coronavirus vaccine clinic at Franklin Sherman Elementary School in McLean, Va. CBS News reported on Saturday that 10,000 U.S. children under

age 12 had received the vaccine in its first 3 days of authorization between Wednesday and Friday – with the Biden Administration purchasing 65 million kid-sized doses.

3. **EMPLOYER VACCINE MANDATE ON HOLD.** On Saturday, the 5th Circuit Court of Appeals in New Orleans granted an emergency stay of the November 5th mandate by the federal Occupational Safety and Health Administration that employees in companies of at least 100 workers, including both full-time and part-time workers, be vaccinated by January 4, 2022, or face mask requirements and weekly tests. The mandate was challenged in court by attorneys general from Texas, Louisiana, Mississippi, South Carolina and Utah, which is 1 of 4 separate challenges to the new regulation brought by 26 states (the other states are: AL, AR, AK, AZ, GA, FL, IA, ID, KS, KY, MO, MT, ND, NE, NH, OH, OK, SD, TN, WV, and WY). 4. **STUDENT LOANS.** Last Thursday, the Biden administration on Thursday moved to terminate the contracts of

companies that collect defaulted student loans on behalf of the Education Department, representing the latest shakeup to the student loan program as officials prepare to restart monthly payments early next year. Rich Cordray, the department's student aid chief, said that the decision to end the contracts with the debt collectors was part of a long-term strategy to improve defaulted federal student loan collections. Mr. Cordray stated that the decision would allow the Education Department "to more effectively support borrowers who are at risk of defaulting

on their student loans" and provide streamlined customer service to borrowers. The Education Department has employed outside debt collection firms to recoup money from borrowers who default on their student loans, though the number has recently shrunk.

## Drake State Launches Welding Bootcamp



The Bureau of Labor Statistics says there are 49,000 welding-related job openings each year, but these openings are the result of welders, cutters, solderers, and brazers transitioning to different occupations or retiring from the industry. To help employers recruit new workers, Drake State Community & Technical College has launched its Welding Bootcamp to help individuals spark a great career or personal hobby.

"This program has become so popular that we had to rollout another bootcamp," said Workforce Development Director Dr. Karen Ray. "The first bootcamp was filled with potential full-time students and engineers looking to advance their skills in a technical trade."

The Welding Bootcamp is an 8-hour experience for only \$300 and it supports Gov. Kay Ivey's plan to grow certified skilled workers by 2025. Participants will learn materials and welding fundamentals and safety from a certified Drake State welding instructor.

"This opportunity is a pathway that can lead to certifications," said Dr. Ray. "Being certified is a needed qualification for today's advanced manufacturing workforce."

Private group classes for people interested in welding are also available for up to 10 participants for a flat rate. Personal protection equipment for all bootcamps can be purchased or rented at an additional cost.



"praise" in Psalm 150, it was the word *Hallelujah*, which means *Praise the LORD!*


Just as James Brown exhorted his listeners to *Say it Loud*, this was David's version of *Say it*


